- 2. The National Information Technology Authority-Uganda (NITA-U) now invites sealed Bids from eligible Bidders for the Enterprise/Integrated IT Service Management and IT Operations Management Solution for NITA U to support the Project.

Bidding will be conducted through the national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, Revised September 2023 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

Interested eligible Bidders may obtain further information from the National Information Technology Authority-Uganda (NITA-U) and inspect the bidding document during office hours (0800 to 1600 hours) at the address given below. A pre-bid meeting, which potential bidders may attend, will be held on 22ND MAY 2024 at 11:00am at the address given below.

The bidding document in English may be purchased by interested eligible bidders upon submission of a written application to the address below and upon payment of a nonrefundable fee of UGX 200,000 (Uganda Shillings Two Hundred Thousand only) or equivalent in any freely convertible currency.
