The procurement process will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers - Procurement in Investment Projects Financing" (July 2016, revised September 2023) and is open to all eligible bidders as defined in the Procurement Regulations.

5. Interested eligible Proposers may obtain further information from National Information Technology Authority-Uganda and inspect the request for proposals document during office hours **0800 to 1700** hours from Monday to Friday at the address given below.

A pre-proposal meeting will be held **04th July, 2024** at **NITA-U Head Office, Palm Courts, Plot 7A, Rotary Avenue** at **10:00am** with an Online Virtual Meeting using zoom – A link will be shared with all registered proposers prior to the date of the meeting. The proposers who wish to attend the meeting shall register and submit their official email addresses not later than one (1) day to the date of the meeting to **udap@nita.go.ug**

The request for proposals document in English may be purchased by interested eligible Proposers upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **Ugx.300,000 (Three Hundred Thousand Uganda Shillings Only) or equivalent in a freely convertible currency**. The outer Proposal envelopes marked "ORIGINAL PROPOSAL", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend, at the address below on **1st Floor Boardroom, 11:15am, 8th August, 2024**. All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public Proposals opening.
